The parents of this puppy have been checked by a veterinarian and cleared as healthy.

Puppy must be paid in full before pick up.

This puppy is sold with a limited / full registration.

Picture Perfect must be added to the puppy's name, unless placed as a pet (limited) then it is not mandatory.

Puppy is up to date on vaccinations and preventative healthcare. Record of care is provided.

Buyer has the right, at the Buyer's expense, to have the puppy examined by a veterinarian of their choice prior to purchase.

Buyer agrees to have this puppy examined by a veterinarian within 72 hours of delivery; failure to do so renders the guarantee contained in this contract null and void.

Buyer agrees to maintain the puppy's health with appropriate food, water, exercise and socialization.

Buyer provides annual vet examinations, vaccinations, monthly heart-worm prevention, pest control and any other usual procedures necessary to assure good health.

Picture Perfect Boxers Guarantee

This guarantee extends from birth to 12 months of age. Covered conditions must meet all three of these criteria: 1) known to be inherited 2) develop during the first 12 months of the animal's life and 3) significantly alter the lifespan of the dog.

Conditions NOT COVERED include, but are not limited to coccidia, giardia, kennel cough, demodectic mange, scabies, pinkeye, allergies and other auto immune system disorders or treatable illness. This guarantee does not cover uneven bites, undescended testicles, Class I insignificant heart murmurs, inguinal or umbilical hernias.

Death due to accident, injury, owner neglect or any other cause will not be eligible for replacement puppy. Picture Perfect Boxers does not assume any liability for any injury to the puppy after delivery or pick-up. There is no guarantee against negligence. Furthermore, the Buyer will not hold the Seller liable for anything outside the scope of this contract.

Veterinary visits and/or medications are at the expense of the Buyer. Replacement puppy cannot be given if the former did not receive normal veterinarian care.

Buyer must notify Seller at the onset of a problem. Buyer must provide a report from their licensed veterinarian which includes: 1) the date the puppy was seen 2) the diagnosis 3) the tests and/or laboratory results or findings of the post-mortem exam.

Seller has the right to have Seller's Veterinarian, or an un-biased second Veterinarian, diagnose the puppy at Seller's expense.

For replacement, the puppy must be returned to Seller (if living). All registrations and rights of ownership are then transferred to Seller.

Buyer agrees to pay all shipping and related costs for returning the puppy and receiving the new one.

No replacement puppy will be given if the puppy has been bred, spayed, neutered, or euthanized without the Seller's permission.

No cash refund will be made under any circumstance.

Replacement puppy will be mutually agreed upon by both parties and be of comparable bloodlines. Buyer understands this exchange might not be immediate, depending on if we have puppies available.

The Buyer hereby agrees that if at any time he/she cannot take proper care of the puppy, the Buyer must contact the Seller and return the dog to Picture Perfect at no charge to Picture Perfect Boxers.

This contract constitutes the full agreement between buyer and seller. It shall be governed and construed in accordance with the law of the State of Missouri and any legal action must be brought in to the county of St François, state of Missouri.

The undersigned has read, understands and agrees to abide by the terms and conditions contained herein. For puppies purchased sight unseen, acceptance of the puppy constitutes a signature and acceptance of this contract.
